2. Resolution 2020-97

Porter on the Lake Tree Removal

3 bids were received for Porter on the Lake to remove 12 dead ash trees, 1 red oak, 1 white oak and to grind down the existing stumps. All wood and debris is to be hauled away upon completion.

Arbor Tree - \$18,500

BL Tree Care - \$18,350

MIS TREE - \$14,800

Motion was made by Deputy Supervisor Baker and seconded by Councilman White to select MIS TREE to remove the dead trees at Porter on the Lake at a cost of \$14,800.

Councilman White also talked about having an arborist come to the park to let the Town know which trees would be good to plant. He talked about possibly placing an ad in the paper to see if people would like to donate a tree in someone's memory.

Motion to adjourn the meeting at 3:20 PM was made by Deputy Supervisor Baker and seconded by Councilman Adamson.
