Supervisor Johnson opened the Public Hearing at 6:04 PM asking if anybody would like to comment on the 2021 Preliminary Budget. Greg Robinson, President of the Youngstown Fire Company spoke up and said that he would like to thank the Town Board for their continued support. He said that the Fire Company is in need of a new ambulance and the cost is around \$200,000. He also said that the Seafood Boil and the Golf Tournament were cancelled this year.

Supervisor Johnston explained that the Governor "really stuck it to us this year". The Town of porter lost \$48,000 in AIM money and \$100,000 in revenue. He also cut highway chips money by 20%. It was not easy to not give our employees a raise but the money just isn't there.

Motion to close the Public Hearing at 6:17 PM was made by Councilman Adamson and seconded by Deputy Supervisor Baker.

Roll call vote was taken and all present Town Board members (Supervisor Johnston, Deputy Supervisor Baker, Councilman White, Councilman Adamson and Councilman Ortiz) were in favor.

Motion to Adopt the 2021 Preliminary Budget was made by Councilman Ortiz and seconded by Deputy Supervisor Baker

There was discussion between highway Superintendent Burmaster and the Town Board regarding new equipment that is needed. Dave would like to see a long term program started on equipment. He feels that the time is now to start purchasing 1 piece of equipment per year.

Councilman Adamson asked Superintendent Burmaster to put a material list together and he would like to see an 8 year plan to purchase all the equipment that is needed.

Supervisor Johnston asked Dave to get information together for Monday's Town Board meeting.

Motion to adjourn the meeting at 6:40 PM was made by Councilman Adamson and seconded by Deputy Supervisor Baker.
