## **Tentative Budget Presentation for 2022**

Town Clerk, Kara Hibbard, to present the 2022 Tentative Budget to the Town Board members.

The budget was presented to the Town Board members and a brief discussion followed. Once the members have had a chance to look at the budget, there will be another meeting set up next week to discuss it more in depth.

Code Enforcer Jefferys stayed for the meeting and said in a letter to Town Board members “as we approach the 60 day deadline (§200-109 of town code) for the Town Board to take action on LL8-21 Rural Residential Business law, I again write in an attempt to engage the Board in further discussion, deliberation and understanding of the proposed law. (Note the public hearing was closed on LL8-21 on Aug 9, 2021 + 60 days = October 8, 2021).”

Supervisor Johnston and the other Town Board members do have some concern over this proposed law and said that they would like to have more input from the Planning and Zoning boards before a final decision is made.
