7. Report 2016-251

Town Board Comments

Supervisor Wiepert: Talked to Hwy. Supt. Hillman this morning, he said that the water tank on Balmer Road is leaking again. We've had it repaired twice in the last year or so at a cost of \$14,000 - \$15,000each time. Hwy. Supt. Hillman wants to know if he can eliminate the tank, mothball it for now? He wants to know what the town board wants to do, repair it or mothball it. I don't know if you can do that.

Right after the first of the year we have to do that water study we have to work on that and see what we are going to do with the new tank. We have the model from CRA, that's our first project for the New Year.

We have had some retirees and resignations in the past year. Sue Dietz is resigned as Historian, Andy Sharpe has resigned from the Recreation Commission, Norm has decided to retire and Rosanne Moje passed away. Joe Fleckenstein has decided to resign from the town board, he submitted a letter of resignation on December 13th, so there are some positions that need to be filled.

Councilman Baia: What are we going to do about Fleckenstein?

Supervisor Wiepert: It was sent back to the Republican Committee. They are supposed to be coming up with a recommendation. We have heard nothing yet.

Water Tank:

Hwy. Supt. Hillman: I made some inquires to David Branch, Niagara County Water District and Dave Britton from GHD. Dave Branch said it isn't just a question of closing the valves off and shutting it down. There are some ramifications health department wise. Both water tanks act as a shock absorber to the system and a quick change in directions sends a shock wave all thru the system and that's a place for it to vent off before it does damage elsewhere.

Dave Branch wants to come out tomorrow to see exactly what it might entail to do the repair. Then they want to feel out what the health department has to say. Let's see what is there first and see if a repair is in order as a stop gap or actually mothball the tank would be a better thing to do.

Town Website:

_Town Clerk DuBell: Talked about the Virtual Town website and asked if any of the board members looked at the site. Councilman White questioned things that he didn't see on the website; I informed him that each website is custom designed to the needs of the user. Bookkeeper Siegrist spoke about the 24/7 customer support that is provided and that they will come in and train people how to use the site.

In a letter they stated that they would be happy to conduct an online presentation of their capabilities, especially the Content Management System, so you can see how easy it is to update their website.

Supervisor Wiepert: Can we do this without going out for bids? I think it is a specialty item and we won't need to go out for bids.

Clerk DuBell will check to see if we need to go out for bids.

Dog Control:

Supervisor Wiepert: The town clerk has been working with Lewiston Town Clerk to come up with the dog control. The Village Vet sent a letter saying that their contract was terminated as of December 31. Lewiston Dog Control Officer Dave Sheriff and Town Clerk Garfinkel have been trying to work things out with them. They will advise us as soon as they have an answer.

The End of the Year meeting was adjourned at 3:22 PM. Motion was made by Councilman White and seconded by Councilman Baker. Motion carried.
